

Notarized Consent Form

Required Additional Documents

Any one under the age the age of 18 who wants a tattoo or piercing done at BODYTECH will need to fill out the consent form and have it notarized. Once the form is notarized, the minor and the parent or legal guardian signing for the minor will need to come into the shop. The following are documents you will need in addition to the notarized consent form.

Everyone Minor and Adult needs to have.

ID! Drivers/restricted licenses are the best. Alternative forms of ID include passports, school ID or yearbook photo WITH birth certificate. If you have any questions about what is an acceptable ID, please call.

Parents whose last name is not the same as the minor.

Will need a birth certificate.

Legal guardians who are not the biological parents.
Ie: Stepparents or Grandparents

We will need the court papers that show the guardian has power of attorney over the minor, and can sign for such purposes.

A minor who has been Emancipated

We need a copy of the papers from the court stating that the child is emancipated from their parents and can make these decisions on their own.

NOTARIZED CONSENT FOR A MINOR CHILD

Florida State law prohibits the Tattooing or piercing of a minor under the age of 18 without written notarized consent from a parent or legal guardian. Said guardian /parent must be present at the time of the tattoo or piercing. BODYTECH tattooing and piercing inc. holds the right to perform certain piercings in a certain age group. Piercings and groups are as follows; 18 and above any piercing Bodytech Inc. has to offer, 17 to 16 any piercing but nipples and genitals, 15, ears, nose, navels, and tongues only. 14 to 13 ears, nose, navels only. 12 and under ear lobes only. BODYTECH Tattooing and piercing Inc. will not pierce anyone under the age of 10. BODYTECH tattooing and piercing inc. does not tattoo under the age of 16.

I agree for myself, my minor child, my heirs, and legal representatives to hold BODYTECH Tattooing and piercing inc. free from all damages, actions and causes of actions, claim adjustments, cost of litigation, attorney fees, and all other fees.

I agree that these waivers are designed to protect the best interest of myself, my minor child, and all establishments where BODYTECH Tattooing and piercing inc. conducts business.

I hereby release any and all persons representing BODYTECH Tattooing and piercing inc. from all responsibility relating to my minor child's Tattoo or piercing. I accept all responsibility for myself, my minor child, my heirs, and legal representatives for any consequences that may arise from my decisions or my minor child's decision to have any piercing or tattoo related services conducted by BODYTECH Tattooing and piercing inc.

I have read each and every paragraph listed above, and with full understanding agree that all information provided to BODYTECH Tattooing and piercing inc. is true and correct to the best of my knowledge. I do not hold BODYTECH Tattooing inc. responsible for the outcome of any procedure, or service done to my minor child.
